APPLICATION

The GS-DC Series 12VDC, 24VDC, and 24VDC high output luminaire is an industrial-grade product suitable for harsh and hazardous locations. Installation areas include indoor, outdoor, and wet locations. Frequent exposure to moisture, dirt, corrosion, vibration, and rough usage is common for this product family. Furthermore, GS-DC fixtures have certifications for use on marine vessels inside, outside, and in other severely wet saltwater environments. Part numbers containing "-HZ-" are approved for use in hazardous locations.

INSTALLATION STEPS

Inspect shipping package and contents to ensure no damage has occurred during shipping.

Adjustable Bracket Mount

STEP 2a.

Use a 3 mm hex key to loosen each M4 pinch bolt (2x) slightly to allow some free movement. This will allow for easier installation on uneven or other surfaces.

*Be sure not to loosen the pinch bolts too far, as they will disengage.

STEP 2b.


Mount the luminaire to the desired location with four 1/4" -20 (4x) screws or bolts (not provided).

Adjust the luminaire to the desired angle and tighten M4 pinch bolts (2x) using a 3mm hex key.


If the application requires periodic aiming adjustment, do not rotate more than 180° in either direction from the installation point; doing so may strain the electrical connections excessively.

Continue to STEP 3.

INSTALLATION STEPS CONT.

Carriage Bolt Mount

STEP 2a.

Align both carriage bolts through holes in the desired mounting surface. Place the provided flat washer, lock washer and 1/4"-20 nut on the bolt and tighten luminaire to the surface.

STEP 3.

For general location installation:


During installation, the supply side of the cord must be terminated with a listed cord connector complying with the NEC/CEC requirements. The cord connector must be rated for use with suitable cable of the types SOW, STOOW, STOOW, STOOW, and SEOOW, having a diameter between 8.75mm/0.345" and 9.4mm/0.370".

The listed cord connector must be installed in a listed box that complies with the installation's NEC/CEC location requirements. The cord connector and box must be rated for the installation environment, which must not exceed the luminaire's wet location IP66/67 rating.

For hazardous location installation:

During installation, the listed cord connector for an outlet junction box with suitable grounding must comply with the installation's NEC/CEC hazardous location requirements. The cord connector must be rated for use with extra rugged usage cable of the types SOW, SOOW, STOOW, SEOW, and SEOOW, having a diameter between 8.75mm/0.345" and 9.4mm/0.370".

The listed cord connector must be installed in the listed outlet box, using a minimum 1/2" NPT hub to comply with the installation's NEC/CEC hazardous location requirements. The cord connector must be connected to the listed outlet box, which has a threaded conduit opening matching the same size as the cord connector. The outlet box must be listed for the installation environment. The installation environment must not exceed the wet location IP66/67 rating of the luminaire.











INSTALLATION STEPS CONT.

STEP 4.



Black: Negative (-) White: Positive (+) Green: Ground

Connect the lead wires from the cord to the field supply wiring inside the outlet box. The field wiring terminations are to be made following acceptable practices as outlined by the NEC/CEC for either the specific ordinary or hazardous locations as dictated by the installation location.

STEP 5.

Energize the luminaire.
